Professor Wallace is an attorney licensed to practice law in the State of California and his professional experience includes appointment as the City Attorney of the City of Fresno, service as the County Counsel for the County of Butte, private practice in a media law firm and experience as a Deputy District Attorney in San Diego, California.

Cliff Roberson LLM, Ph.D is Editor-in-Chief, Professional Issues in Criminal Justice Journal and is academic chair for the Master of Science in Criminal Justice Program, Kaplan University. He is also an Emeritus Professor of Criminal Justice at Washburn University, Topeka, Kansas.
